MOST DISTINGUISHED PHYSICIAN AWARD

The MDPA is the highest award that can be given to a Fellow of the PCP in recognition of outstanding local and international achievement (past or present) as a practicing internist, researcher, teacher, health care advocate or community developer leading to the advancement of Internal Medicine as a specialty. The award may be given posthumously. This being the highest award, those who will be granted this award are no longer eligible for other categories of the PCP Exemplars awards. The Award is given to a Fellow of good standing who is an exemplar in three or more of the following roles as Internist, Teacher, Researcher, Healthcare Advocate or Community Developer. It is not mandatory that there be an Awardee for the MDPA for a given year.

This award will be given to a Fellow of the PCP for peer-recognized outstanding achievements in the following areas:

- a) recipient of a PCP Award / Subspecialty Award;
- b) professional recognition in the field of academe, administration, or international position;
- c) service to the PCP;
- d) civic and community involvement.

Nominations for this award can NOT be made directly for this award. The nominee list is generated from those who meet set criteria for three or more of the other PCP Exemplar awards. Please nominate your choice for the other awards.
